

Introduction: The Scandinavian Barrow Cemetery at Heath Wood


The cemetery at Heath Wood is set within Forestry Commission woodland on the western edge of the parish of Ingleby in Derbyshire (Maps 1 and 2). It is the only known Scandinavian cremation cemetery in the British Isles, dating to the ninth century AD. The site comprises 59 barrows, of which one-third were excavated prior to 1998. Although all of the barrows had burials associated with them, only some contained pyres. A number of the barrows investigated had surrounding ditches. From 1998 to 2000, three barrows (numbers 21, 50 and 56) were examined. The location of these is marked on Map 2.

Pyre: a heap of wood on which a corpse is burnt

Using Figure 4 as a guide, identify the following features on Figure 5:

- (i) Section P
- (ii) Area Q. (2 marks)
- 5 Study Figure 4 and Figure 5.

Using the conventions in the plan as a guide, draw and label a profile along line X - Y as marked on **Figure 4**. (5 marks)

6 Study the Introduction and **Figures 1** to **5** and use your own knowledge.

Outline the particular issues that archaeologists may have faced when working in an area of woodland. (6 marks)

7 Outline the most useful geophysical survey techniques to investigate a barrow cemetery in open country. (11 marks)




