Answer Question 1 and **either** Question 2 **or** Question 3. Each question has **two** parts. Answer **both** parts of each question chosen.

Question 1

Study the following source material and then answer the questions which follow.

- **Source A** The mass shootings by the *Einsatzgruppen*, on the orders of Himmler and Heydrich, were the first horrific phase of genocide. However, by the autumn of 1941, the genocide extended beyond the occupied parts of the Soviet Union and rapidly entered a second phase. The Nazis aimed at nothing less than the physical
 - 5 extermination of the Jews of the whole of Europe. This is what the Nazis would label the 'Final Solution of the Jewish Question'. The untold misery, suffering and death inflicted on Europe's Jews followed from two crucial decisions – or, more precisely, sets of decisions – in 1941. The first of these, in the summer, was to kill the Jews of the Soviet Union. The second, in the autumn, was to extend the killing to the whole 10 of Nazi-occupied Europe.

- **Source C** The deportations that resumed on a large scale in the spring of 1942, after the Wannsee Conference of 20 January, were preceded in January and February 1942 by a series of public declarations by Hitler in which he unambiguously returned to his 'prophecy' of January 1939, according to which the Jews of Europe would be
 - 5 exterminated if there was a new world war. Both the recent entry of the USA into the war (meaning the war had been extended to a world war), and the fact that in his statements Hitler continually assigned the date of 1 September 1939 to his prophecy, underlined his threat towards the Jews.
