Question 1

Study the following source material and then answer the questions which follow.

Source A Adapted from a speech by Malcolm X in Detroit, in February 1965

The Klan is a cowardly bunch. It has perfected the art of making negroes afraid. As long as the negro is afraid, the Klan is safe. But the Klan itself is cowardly. One Klan member will never come after one of you. They all come together. They're scared of you. Since the federal government has shown that it isn't going to do anything about the Klan but talk, then it is a duty, it's your duty and my duty as men,

5 anything about the Klan but talk, then it is a duty, it's your duty and my duty as men as human beings, it is our duty to our people, to organise ourselves and let the government know that if they don't stop that Klan, we'll stop it ourselves.

Source B

Testifying before a US Senate Committee in the 1960s, former US Attorney General Nicholas Katzenbach summed up the 'unique difficulty' in Mississippi and parts of Alabama and Louisiana of 'gathering information on fundamentally lawless activities'. Ku Klux Klan activities had the sanction of local law enforcement agencies, political

- officials and a substantial segment of the white population. The murders of Medgar Evers, Viola Liuzzo and other Klan victims were initially helpful to the Klan. The Klan drew its membership almost exclusively from that resentful part of society that looked on physical resistance as the necessary and suitable expression of whites at a time of challenge. Violence swelled Klan ranks. There was also a wider pool of
- 10 supporters who saw the Klan as the only organisation that did anything to counter the black encroachment into their lives.

0 5 Explain why there were race riots in major American cities in the years 1965 to 1967. (12 marks)

and

US politicians did little to improve the lives of urban blacks in the years 1964 to 1968.'

Explain why you agree or disagree with this view. (24 marks)
